#### Introduction 1.

Kolhapur District Central Co-operative Bank Ltd., (KDCCB) Kolhapur is a District Co-operative bank in Western region of Maharashtra. The bank is having 191 branches and Head Office have computerized entire operation using Core Banking Solution. KDCC Bank (herein after called 'the Bank) is inviting quotations from provider for AMC of Hardware and Network Peripherals.

This tender is meant for the exclusive purpose of bidding as per the terms and conditions and scope of work indicated. It shall not be transferred, reproduced or otherwise used for purposes other than for which it is specifically issued.

#### 2. **Detailed Scope of Work**

- 1. AMC is comprehensive for one year & onsite in nature and consists of all spares, material and manpower required for smooth functioning of Hardware & Network.
- 2. The AMC of 191 Branches & Head office has divided into 4 divisions(A,B,C,D) consisting of 547 hardware & network items and will be allotted to the bidder/bidders.
- 3. The list of branches is attached with Annexure-8 List of Branches With Hardware & Network Details.
- 4. Bidder has to provide Helpdesk Management Facility System for calls regarding Maintenance. In addition to this Bidder has to provide residence engineer at division level.
- 5. As part of this solution and offering, Bidder has to carry out preventive maintenance, repair of hardware and network peripherals mentioned in this tender document.
- 6. Bidder/Bidders has to do preventive maintenance quarterly.
- 7. Bidder has to attend local calls within 2 hours and outstation calls within 4 hours of its reporting. If calls are not completed within stipulated time, then Penalty shall be charged as per SLA.
- 8. Bidder has to provide qualified and experienced engineers for day-to-day support for Networking & Hardware of the bank.
- 9. Bidder has to provide dedicated Senior project coordinator with contact numbers for smooth functioning of support and services.
- 10. Spares or material supplied as part of this tender must be legally obtained by the bidder/bidders.
- 11. There must not be any third party violation of IPR of Operating System / Microsoft Office/any third party non-licensed product. Any third party software licenses installation at branches or offices required to have written permission from IT Dept. of the bank.
- 12. Bidder/Bidder's engineers should get in touch with bank's data, information, record, hardware while executing this task and project, Bidder/Bidder's engineers should not modify, transmit, disclose the same in any manner. The breach of the same may lead to a legal action against bidder.

#### 3. **Evaluation Procedure**

- A. Eligibility Evaluation
- B. Post eligibility evaluation commercial bid will be opened for all the eligible bidders and declare the

LOWEST COMMERCIAL PRICE quoted bidder as the WINNER and award letter issued to the Firm/Company. Bank may negotiate with the Lowest commercial quoted by the bidder before issuing award letter.

- C. Bank may reject the RFQ process any time without any reason to bidders. Bank's decision is final. Incase If after evaluation of Bids, bank end-ups with one responsive bid only. In such situation, the bid process shall be considered valid even if there is one responsive Bid, provided that: -
- a. The Bid is technically qualified.
- b. The price quoted by the bidder is assessed to be reasonable.
- c. The Bid is unconditional and complete in all respects.

#### vii. Bid Security - Earnest Money Deposit (EMD)

#### xii. Pre-Bid Meeting:




